Taking a proactive approach to security to exceed compliance requirements

Government contractor Traxyl needed to ensure its operations were both secure and compliant with prominent industry regulations like the US Department of Defense's Cybersecurity Maturity Model Certification (CMMC) and International Traffic in Arms Regulations (ITAR). The addition of MXDR ensured 24x7 coverage over their systems.

The result is nearly 50% coverage of CMMC technological control requirements, all from a single security platform, with similar coverage for ITAR as well. The remainder were easily handled by Queen's expert team.

Because of Queen's efforts, Traxyl exceeded its compliance requirements and was awarded multiple large DOD contracts. The influx of new business at this scale helped Traxyl grow its team from just five employees to 25.
